## **HOW TO APPLY FOR FREE SCHOOL MEALS - 2016/17**

What you need to do:

1. Complete the application form fully. You MUST provide all the information we have asked for so that we can carry out a benefit check. You <u>do not</u> have to send in evidence of the benefits you receive.

Your child may be able to get free school meals if you get any of the following:

- Income Support. (This can be a letter or a recent bank/building society statement showing a credit for 'DWP IS').
- Income-based Job Seekers Allowance / Income-related Employment & Support Allowance.\*
- Child Tax Credit (assessed on the basis that your income is less than £16,190 before tax and any other deductions)
- · Pension Credit.
- Support under part VI of the Immigration & Asylum Act 1999.
- Universal Credits
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit

\*Please Note: \*If you receive any Income Based JSA or any Income related ESA, you qualify for Free School Meals

You are not eligible for Free School Meals if:

- You are not claiming one of the benefits from the list above
- You receive Working Tax Credit (excluding the 4 week run on)
- Or, your Household Income is over £16,190 (annually before tax and any other deductions)

Children who get any of the above benefits in their own right (i.e. they get benefits payments directly, instead of through a parent or guardian) can also get free school meals.

Children under the compulsory school age who are in full time nursery education may also be able to get free school meals.

2. If your child attends a Bournemouth school, please return the completed form to:

When we receive your completed form:

- 1. Once we receive your completed application for Free School Meals we will check your benefit entitlement with data held by the Department of Work and Pensions, the Home Office and HMRC (Revenue and Customs) through a central Eligibility Checking System (ECS). If we cannot confirm your entitlement though this process we will write to you to ask you to provide up-to-date evidence of the benefit you receive.
- 2. We will inform you in writing whether or not your child/children are entitled to free school meals.
- 3. We will inform your child's school of the Free School Meal eligibility.

Your child/children will receive free school meals while you are in receipt of one or more of the qualifying benefits listed above.

If this benefit stops, or your Tax Credit Award is reassessed, you must inform us [Local Authority] immediately.
