Students accessing on-site provision during lockdown:

Students should not attend the academy if they, or a member of their household is displaying any symptoms of coronavirus.

Uniform, equipment and lunch:

- It is expected that students will be in full uniform including face mask.
- Students will arrive with the correct equipment for learning the academy will be unable to lend this.
- Students will be expected to bring either a packed lunch with them (including a drink(s)), or have money on their SQUID account to purchase food from the canteen.


Students will be expected to:

- Arrive to school for 8.25am and remain for the whole day.
- From Mallard Rd (outside the school) ensure they follow and adhere to the distance markers on the pavement and walkway(s).
- Wear their mask at all times within the Academy building.
- Make way to their allocated room, sanitising / washing hands before entry to the room.
- Respect social distancing at all times.
- Remain in their 'bubble' and classroom for the time they are in school.
- Engage fully in their learning, following the timetable for their year group, where necessary follow the live lessons (ensuring they have brought headphones in to do this).
- At break / lunch, if weather is ok students will be able to go outside to their allocated area, but will not be able mix with students outside of their 'bubble'
- At home time students collect all their belongings, wash hands / sanitise and leave the academy site, heading straight home and not waiting for others; again respecting social distancing.
- Follow social-distancing expectations at all times and not put themselves or others at risk.
- Behave appropriately and in accordance with our 'Culture for Learning' policy.

Parents / Carers will be expected to:

- Send their child to school for the agreed time, in uniform, with a packed lunch and a drink(s), or ensure their child has money on their SQUID account to purchase food from the canteen. Students who are entitled to a free school meal will be able to order this for collection from the canteen.
- Ensure that if their child is taking medication currently they have it on them and know how to take it we will not be able to administer medication to your child during this time. Medication must continue to be named and have clear instructions on.
- Understand that they will not be allowed onto the school premises, but must continue to communicate with the Academy via phone / text on the following numbers: 01202 512697, or email to <u>office@tbowa.org</u>
- Understand that if their child displays any symptoms of Covid-19 they will be immediately sent home, even if we are unable to contact you this is for the safety of other students, their families and our staff and their families.
