
## Dear Parents and carers

As you may be aware, the National Education Union has balloted its members to take industrial action. We were notified of this decision on Monday 16<sup>th</sup> January and a number of parents have started to ask how we intend to respond to the situation.

Schools have been given notice of the following proposed days of action:

- Wednesday 1<sup>st</sup> February 2023
- Thursday 2<sup>nd</sup> March 2023
- Wednesday 15<sup>th</sup> March 2023
- Thursday 16<sup>th</sup> March 2023



I must stress that the strike does the relationship between staff and senior leaders and governors, which is positive and productive. We have highly dedicated staff, but many of them feel strongly about this issue and the impact funding is having on pay and the profession.

At this juncture I cannot confirm to you of the exact impact of the strike action. Striking staff do not have to notify their employer until the day of the action, therefore, despite the information already provided by some staff, the position for Wednesday 1<sup>st</sup> February remains uncertain. Teachers who are not on strike may be asked to cover the classes of those taking industrial action, however, they are under no obligation to undertake these cover classes.

The decision around the provision we can provide on a strike day will be taken following an effective risk assessment considering the safety of staff and students.

We are also looking at the school calendar and the events that may be affected by strike action and will keep you updated of any changes.

The academy will be doing all that we can to keep the academy open for as many students as possible on the days affected, as we believe that continued attendance is important for all students. However, the numbers of staff on strike may mean that we will need to temporarily prioritise places for vulnerable children and the children of critical workers.

To assist us in determining the nature of the on-site provision that we will be able to offer on the four days of industrial action (and any subsequent days), we are asking parents/carers to complete an online form if they believe that they are a critical worker and require their son or daughter to be accommodate in school when there is industrial action. Please complete and submit the form by 4.00pm on Thursday 26<sup>th</sup> January. We will be unable to offer provision for any child of a critical worker on any of the days of which have already been advised, or any subsequent days when industrial action takes place unless the form has been submitted on time.
